PRESIDENT'S REPORT



Our Vision...

A society committed to the prevention of dementia while valuing and supporting people living with dementia

The past year has been a constructive one, with your Board adopting a new five year Strategic Plan to take us through to 2016.

During the year your Board supported the development of a new more aggressive marketing and branding strategy for Alzheimer's Australia- you will see evidence of it throughout this Annual Report. The brand sends a clear message- we have declared war on dementia !!! We need to fight the disease and its causes; to fight the lack of awareness that leads to such distress for many families; to fight for more funding for dementia research and dementia specific services.

This fight is particularly important right now as the Federal Government responds to the Productivity Commission Report on Caring for Older Australians. There are no dementia specific proposals in that report and this poses a real threat to the vision for dementia services.

In 2005 the previous Liberal Government established the Dementia Initiative which has been the envy of many other countries. The Dementia Initiative ensured that funding was quarantined for education and support services related to dementia and that dementia was viewed as a clearly defined national health priority. We are concerned that this focus may be being lost through the proposed aged care reforms with damaging impacts on dementia services and with particularly worrying implications for the increasing number of younger Australians being diagnosed with younger onset dementia.

It was encouraging to see so many of our members respond to the consultations about aged care reform and we will

continue to work to ensure we retain our consumer focus.

Of continuing concern is the failure of the Northern Territory Parliament to enact legislation which will enable people who have been diagnosed with dementia but are still cognitively competent, to put in place clear, enforceable advance directives about a variety of lifestyle and medical issues to cater for their future. Citizens in every other State and Territory in Australia have that capacity and our members should be enraged that they and their families are being denied the comfort such advance directives would provide.

Whilst I will remain a supporter of Alzheimer's Australia NT, I am stepping down from the Board at this AGM and wish to thank all our board members for their continued support throughout the year. It was wonderful to have Dr Sadhana Mahajani join our Board during the year. Her psychogeriatric medical expertise is most welcome and her commitment to our goals is inspirational.

I would also like to thank our overworked and underpaid CEO and all of her staff for the wonderful job they have done through the year.

CHIEF EXECUTIVE OFFICER'S REPORT

This Annual Report will provide information to our members and other stakeholders about our activities, and will:

- Discuss activities, challenges achievements during the year;
- outline future directions; and
- summarise progress.

Activities and Achievements

The business plan developed in June 2010 had the following objectives:

- Ensure that contractual obligations are
- maintain the quality system which was implemented in January 2010;
- extend services by submitting funding applications and delivering services outside funding agreements for a fee;
- collaborate with other NT dementia service providers;
- collaborate with SANT Dementia Training Study Centre to ensure health professionals receive relevant dementia training in the NT;
- explore research partnership possibilities with NT institutions;
- maintain good communication with and support for the Alice Springs office; and
- focus on raising awareness about dementia by working closely with the rest of the Alzheimer's Australia federation, utilising expert assistance and regular radio communication via Territory FM as well as participating in the development of a new website for Alzheimer's Australia.

Contractual Obligations

The targets set in funding agreements were met and reported against in a timely manner. These included:

- Home and Community Care Darwin & Katherine:
- Home and Community Care Alice Springs & Tennant Creek;
- National Dementia Support Program;
- Dementia Care Essentials;
- Dementia Community Grant round 3;
- Minor funding agreements.

Quality System

Alzheimer's Australia NT maintains a quality system which maps to the current HACC service standards. Systems are reviewed and updated in response to need. Any changes are documented.

Complaints have been addressed and systems altered as necessary. When systems are changed feedback is sought and further fine tuning occurs to ensure the new process is working well.

Service Extension And **Fundraising**

Fee for service programs, fundraising and sponsorship initiatives were implemented. The P3 for Aged Care course was delivered in Darwin and the dementia module from the Certificate III aged care delivered (for a fee) for Charles Darwin University in remote communities. A Raffle was run at the Katherine Expo. Sponsorships were

provided by local businesses in support of the Baroness Susan Greenfield dinner, which was held in July 2011. Sales of Looking Out for Dementia have been steady.

Marie Gray has made a significant donation to support our Darwin library and we are grateful for her generous support.

Three funding applications have been submitted. Two submissions were successful and one unsuccessful.

Inter-Service Collaboration

Staff attend the Dementia Framework Reference Group, Darwin Aged and Disability Network, Council Of The Ageing GLBTI Round Table and NT Dementia Behaviour Management Advisory group meetings. New staff are oriented to other dementia services and Alice Springs staff attend local network meetings.

SA NT Dementia Training Study Centre (SANTDTSC)

A collaborative approach is required between SANTDTSC and Alzheimer's Australia NT to ensure that information/ education targets gaps in the NT. To support this we have delivered joint events with the Study Centre. For example, Cameron Camp provided his Spaced Retrieval course via video link from Ohio to CDU in June. Feedback from this training was positive and we are pleased to have been part of this innovative mode of delivery.

Research

Consumers have been encouraged to

participate in the dementia research network and staff presented at the Australian Association of Gerontology NT as well as the Alzheimer's Australia National conference. Alzheimer's Australia NT facilitated a session with potential participants in the Dominantly Inherited Alzheimer's Network (DIAN) study being conducted by Prof Ralph Martins through the McCusker Foundation, WA.

Alice Springs Service

Regular contact is made with Alice Springs staff who have provided some excellent input to service improvement discussions. A submission was successful to provide a people mover to transport clients in Central Australia by Alice Springs staff.

Awareness Raising

Darwin office staff participated in the Activate NT initiative again, holding 10 Memory Walks along the Nightcliff foreshore, 10 walks in Palmerston, as well as dementia risk reduction information sessions in both Darwin and Palmerston in early 2011. Staff continue to participate in regular radio interviews at Territory FM on the first Wednesday of each month at 10:20am. The Katherine Expo in June was a lot of fun and a great opportunity to provide information about the support available in the region.

A considerable amount of work was done throughout the year on the re-development of the Alzheimer's Australia website with NT staff assisting with the publishing of national content and updating dementia information. NT pages have been reviewed to provide up-to-date dementia

information and have increasingly been used to advertise events and job vacancies.

Challenges And Key Issues

Dementia is one of the main chronic disease issues of the 21st Century and yet it is not recognised as a chronic disease. This must change and efforts intensified in finding better treatments, preventative strategies and ultimately a cure.

There is concern that the Commonwealth Government has eliminated the budget line relating to the National Dementia Initiative in the year the first Baby Boomer's turn 65.

Hospitals can be dangerous places for people with dementia. The health care system must change to manage the unique difficulties that face people with cognitive impairment more effectively.

The transition of aged care to the Commonwealth with disability being retained by the states and territories raises questions about how people with younger onset dementia will be cared for. There is a risk that service gaps will occur and this group will be unintentionally disadvantaged, especially since younger onset dementia is less common and the population in the NT is small.

Palliative care is not provided as well as it might be for people with dementia. Good quality end of life care is a basic human right. It is important that the dying process is managed in a way that gives people confidence that they will be treated with respect and their pain or discomfort managed well.

SUPPORT SERVICES

Alzheimer's Australia NT Support Services are funded through the Australian Government's National Dementia Support Program (NDSP) and the Northern Territory Government's Home and Community Care (HACC) program. They are primarily delivered in Darwin and Alice Springs, however, from this year funding was provided to extend services to Tennant Creek and Katherine.

NDSP and HACC reports were successfully submitted with established service targets being met during the 2010/11 financial year. The new Katherine service has progressed satisfactorily and is on track to being established and meeting targets in the 2011/12 year.

The NDSP funds the following services:

- National Dementia Helpline;
- counselling and support;
- early intervention strategies, including the Living with Memory Loss Program;
- specialised dementia library;
- social, recreational and therapeutic activities through our Dementia and Memory Centres, for example: Memory Matters, Social Group, Therapy group, Memory Walks, public awareness raising activities and dementia information sessions.

Group and individual counselling targets were exceeded by an average 302% this year, with 158 sessions delivered to 166 people.

AlzANT Support Services team has been involved in many activities throughout 2010/11 and has worked collaboratively with many organisations. We assisted Carers NT to compile their Top End Dementia Services Directory as well as con-

ducting activities during Carers month. Liaison with NTDBMAS and ACAT ensured the best possible support and referral for clients. AlzANT has contributed to various promotional and awareness raising activities jointly with Darwin City Council, including Activate NT and Seniors Month. Staff carried out their specific duties with enthusiasm and expertise.

Seniors Month, held in August each year, continues to grow in popularity with locals and visitors alike. This year, Alzheimer's Australia NT worked in partnership with Darwin City Council to provide two sessions for seniors that encourage a 'brain healthy' lifestyle. The program was held at the beautiful Jingili Water Gardens and included a mixture of exercises to challenge both mind and body.

This included:

- Mind Your Mind presentations
- Tai Chi
- Puzzles and quizzes
- Ball and balance exercises
- A walk through the water gardens

The day concluded with a chance to socialise over a healthy lunch. The event was a huge success and a great testament to both partners working well together.

Darwin hosted a CALD Morning Tea for 75 local seniors with funding from the Department of Health and Families. The event was held at the historic Burnett House at Myilly Point, Darwin. Guests enjoyed the music, Devonshire tea and the opportunity to wander through the house and reminisce.

during Seniors Month. This inaugural visit under new HACC funding enabled them to introduce themselves to new clients and touch base with current clients.

Alzheimer's Australia NT organised an outing for carers during Carers week in October on Duckabout tours, followed by a BBQ lunch in the George Brown Botanic Gardens.

Dementia Awareness Week

The Greek Orthodox Hall at Nightcliff metamorphosed on Thursday 16 September when Alzheimer's Australia NT held its Annual Tea Dance to mark Dementia Awareness Week. The Andrews sisters (aka Jenny Rees and Linda Masters of Hidden Agenda) paid homage to the swing era, performing sensational songs from this grand period. Well over 100 people attended the event, dressed to the nines in line with our Swing theme. We were also entertained by the Groovy Grans, Essington Junior School choir, and the Alzheimer's Australia NT Exercise Group, who performed Strip the Willow.

DAW Events Alice Springs

September was a very busy month for staff in the Alice Springs office as Dementia Awareness Week was marked by two special events. Approximately 24 people attended "Art Day" at the Residency. Painting and lunch was the order of the day - and many of the participants proudly took their artwork home with them. An Alice Plaza display was held in conjunction with NTDBMAS and attracted many enquirers, keen to learn more about issues such as risk reduction and memory loss.

Recreational Therapy Sessions

Sessions this year included Animal Therapy and Creative Therapy, in which professional artists generously gave their time and expertise over six months to enable participation by clients and carers. We thank them for sharing their knowledge and love of the arts with us. Horticultural Therapy commenced in May 2011, following Darwin City Council approval to use a portion of the Nightcliff Community Centre grounds and generous funding from the Dementia Behaviour Advisory Service (DBMAS). We set about creating "Our garden" which is maintained by the Therapy, Stepping Out and Social groups, as well as staff and volunteers.

AlzANT holds Health and Wellbeing and Memory Matters activities on the first and second Friday of each month. Health and Wellbeing is comprised of a guest speaker and relaxation or gentle exercise activities whilst Memory Matters requires participants to complete various puzzles and games. The two hours sessions have become very popular with the general public, with up to 22 participants attending.



Alzheimer's Australia NT was the beneficiary of a Dementia Community Grant from the Department of Health & Ageing, in partnership with Corrugated Iron Youth Arts (CIYA).

A portion of this funding allowed Corrugated Iron Youth Arts to facilitate a series of drama workshops for Alzheimer's Australia NT respite group members and people living in residential care facilities in Darwin.

HOME & COMMUNITY CARE

AlzANT staff also presented a session at the 2nd Annual International Arts and Health Conference. The presentation, "Montessori Principles in Aged Care" described the process of creating a board game in a therapy group and the benefits of this activity.

Home and Community Care (HACC) Darwin & Rural

Home and Community Care (HACC) funds the following services in Darwin and the Rural area:

- Day Respite
- Individual counselling and support;
- Transport

- Dementia monitoring program; and
- carer support groups.

HACC hours of respite, transport and social support increased in this financial year due to each of our respite groups being full throughout the year, giving us a considerable increase in both respite hours and transport. A key factor in the increased need for Social Support for clients was the waiting period before Community Aged Care Packages and other services could be put in place.

Life Memory Albums



The newly received funding for HACC services in Katherine supports:


Counselling, support, information, advocacy and case planning

EDUCATION SERVICES

Alzheimer's Australia NT has moved into new and exciting programs with the introduction of the P3 and the Charles Darwin University (CDU) contract for the delivery of dementia training in remote areas. At the same time, Education staff continue to provide high quality education services throughout the Northern Territory.

Charles Darwin University Contract

Alzheimer's Australia NT was successful in obtaining a contract from Charles Darwin University (CDU) to provide Dementia training as a unit of the Certificate III in Aged Care to four remote communities in Arnhem Land. The first Community where this education program was delivered was at Galiwinku on Elcho Island. Elcho Island is part of the Wessel Islands off North-East Arnhem Land. Other communities covered by the contract were Gapuwiyak, Beswick, and Ngukurr. This venture into Indigenous communities was very successful with feedback from the Aged Care Coordinators being very encouraging, for example "It is fantastic that six of our staff were deemed competent during the two training sessions in Galiwin'ku. All the feedback received from our staff was great and I would like you to know that I have noticed a marked improvement in the way our staff deal with clients with dementia and challenging behaviour." - Yvonne Sutherland Aged Care Coordinator Galiwin'ku. CDU has indicated an extension to this program in year 2011/12.

Dementia Care Essentials (DCE)

Dementia Care Essentials is a project funded by the Department of Health and Ageing (DoHA). The project was renewed by DoHA in December 2010 and runs until the end of May 2011.

The project aims is to deliver nationally accredited dementia units in both certificate III and certificate IV in Aged Care. All targets set by the DoHA contracts were met, including thirty (30) students who successfully completed the Certificate IV unit, and fifty-five (55) students who completed the Certificate III unit. DCE training was provided in Darwin, Alice Springs, and Katherine.

Naukurr CDU class March 2011

P3 Tasmania

Alzheimer's Australia NT has commenced providing P3 (Prevent, Plan, Protect) training in collaboration with DBMAS (Dementia behavioural management Advisory Service) and Alzheimer's Australia Tasmania. The P3 is a course to train workers in the management of aggression and behavioural management, particularly for Residential Care Workers. Two courses were presented this year. Four NT staff were trained by Alzheimer's Australia Tasmania to present this course.

"At Risk" Program

Enabled by a supplementary NDSP Grant from the Department of Health and Ageing.

This program provides basic dementia information and risk reduction strategies to a target group of people engaged in drug and alcohol rehabilitation programs in Darwin, Katherine and Alice Springs as well as correctional facilities in both Darwin and Alice Springs.

The monthly visits to the Darwin Correctional Centre to provide presentations on Mind Your Mind and an overview of Dementia have been well received.

Regular presentations on dementia and risk reduction strategies were also made to CAAPS (Council for Aboriginal Alcohol Program Services Inc.) and FORWAARD (Drug & Alcohol Education & Counselling) in Darwin along with Vendale the residential drug and alcohol program in Katherine region, CAAAPU (Central Australian Aboriginal Alcohol Programmes Unit and DASA (Drugs and Alcohol Services) in Alice Springs.

National Dementia Support Program

Funding under the extended National Dementia Support Program (NDSP) has enabled a range of educational presentations made to raise awareness of dementia.

These sessions have included:

- Information sessions to community groups on dementia and brain health;
- Short courses for workers and participant;
- Community Education sessions for the public and for people considered to be at risk;
- Carer Education for family carers and participants;
- Community displays throughout the Darwin, Katherine and Alice Springs regions; and
- Morning tea for Culturally Diverse Seniors

Testimonial A

I would like you to know that I have noticed a marked improvement in the way our staff deal with clients with dementia and challenging behaviour.

For example: one elderly lady with dementia, who I have tried to provide service based respite for two days per week: but her challenging behaviour (running away at the first opportunity, demanding to be taken home every 15 minutes and who slaps herself continually when staff do not do as she requested) is usually taken home at the earliest opportunity; when often coincides with a visit by me to the health clinic or shire main officer. Last week, staff capably managed her behaviour and she stayed for the entire day, which was a fantastic respite break for her family. When I congratulated staff on how well they had managed and how long they had kept her away from her family to give them a break, staff talked about how they better understood what was happening and how importantly it was to keep her busy and occupied and interested in things. Also they talked about taking her for short rides in the car when she insisted on going home, and they brought her back to the service where she was happy to stay for another couple of hours. It is truly rewarding to witness the changes that the training is making!

I would really like the remaining four staff to have the opportunity to complete the Dementia training in the near future, as the number of clients with dementia being diagnosed is increasing. Late March or April would be a suitable time for is, as we have a range of training happening in February and early March.

The log Books have arrived and I have only had a brief moment to look at them, though I plan to look at them further and discuss them with individual staff next week, before scanning the summary documents for our Human Resources staff to be placed in staff records.

I am pleased that you felt very welcome on your first visit on community. The Yolngu staff at Galiwin'ku are great and Ray's previous relationship on the community, certainly made it easy for both of you to be welcomed 'back' into the Yolngu community. Relationships are very important here, as you would have discovered.

Testimonial B

"I would like you to know that the dementia training is having ongoing effects in our community.

As you are aware (name) attended and satisfactorily completed the Dementia Awareness Training. The training has had a strong impact in (name) as in his clan are a number of men and women who have a had a strong history of alcohol abuse and he is now aware if the impact this has had.

Last week one of his close family members with a history of alcohol abuse had an incident in the Centrelink office, which resulted in him being arrested by police and jailed in Galiwin'ku. When this news was quickly relayed to (name), he independently sought assistance from the Miwatj Mental Health Nurse (name), as (name) was aware that his family member had been from attending Centrelink for a year, and (name) believed he would fall to meet this obligation due to his memory problems.

(name) suggested that they meet with me and together we could develop a

plan to help this family member which we did. (name) was able to negotiate with the Police for the release of his family member, explaining the memory issues and outlining the plan we had developed. I also met with the Centrelink Manager to raise the issues and explained that due to long habits and memory problems from alcohol abuse, the family member would likely continue to access Centrelink on a daily basis, and when he did just politely ask him to go to 'Aged Care" where we would put in place the other aspects of

However, the Centrelink Manager is feeling insecure about his continued attendance at the Centrelink Office, so tomorrow morning at 8:00 am (name), (name) and myself are attending a meeting at Centrelink to hear their concerns, explain the issues for them, give them some fact sheets on alcohol related brain damage and provide them with some training about effectively dealing with the family member. (Name) is feeling secure in his understanding of dementia and is not unduly stressed, when in prior circumstances this would cause a big argument community disturbance. This is such a positive example of how empowering the training has been and supports the need for a broader community awareness of dementia.

STRATEGIC DIRECTIONS & **GUIDING PRINCIPLES**

East Arnhem Shire Council

Nearly 270,000 people currently live with dementia in Australia and without a significant breakthrough that is expected to soar to nearly 1,000,000 by 2050. Each week there are 1,500 more people in Australia who need support. Dementia is now the third leading cause of death in Australia after heart disease and stroke. Dementia is fatal and there is no cure. Making dementia a national health priority is vital, if we are to have any hope of being able to provide appropriate services to people with dementia in the future.

The strategic direction of Alzheimer's Australia NT is aligned with the strategic direction of the National organisation. The board of Alzheimer's Australia NT has decided that the strategic plan developed in 2008 is still valid and has adopted it again for five years from 2011 to 2015. Annual business plans reflect the principles contained in the strategic plan and focus on the key priorities identified by the board, staff and consumers for each business year.

The key focus areas and guiding principles are listed below:

Focus

- Advocacy and empowering consumers
- Quality dementia care
- Understanding and awareness of dementia
- Prevention, risk reduction and delayed onset of dementia
- Organisational sustainability

Guiding Principles

People living with dementia, their families and carers have the right to:

- Access high quality support services;
- Access flexible, responsive and timely support services;
- Be treated with dignity, courtesy and respect, to have their feelings validated and their choices and individual beliefs respected: and
- Access services that support both the person with dementia and their families, ensuring that the needs of the person with dementia are the primary focus and priority.

Future Directions

In the period July 2011 to June 2012 Alzheimer's Australia NT plans to:

- Continue strong support for Alice Springs with an emphasis on meeting the needs of the target group identified in the HACC contract
- Continue to focus on quality and continuous improvement to systems in response to issues as they arise;
- Continue to engage in research projects as opportunities arise;
- Continue collaboration with the SANT DTSC to provide tertiary level dementia education;
- Submit an application to become an approved provider this financial year with a view to providing expanded community care support in the future;
- Continue to raise awareness about dementia issues and support available in the NT:
- Collaborate with other dementia service providers to promote comprehen-

sive support for clients;

- Continue to seek funds to expand services and build our asset base. In particular services for people with Younger Onset Dementia, Indigenous communities and people living alone in the community;
- Meet contractual obligations and work with funding bodies to promote good quality services which meet the needs of clients; and
- Diversify the Association's income stream and increase the asset base.

Summary





Our Financial Results

Total funding received for the 2010/2011 financial year grew modestly over the previous year due, largely the result of indexation in grant funding and larger than estimated Association source income. Total revenue was 4% above estimate.

Increased expenditure over the previous year reflects growth in personnel costs flowing from wage increases and temporary increases in staff numbers to facilitate program delivery. Operating costs in total were 1.5% below estimate.

The higher than budgeted income has combined with lower than budgeted expenditure to deliver a significantly





better than estimated net deficit for the year. The Association's financial position and liquidity remain sound.

Our Challenges

While own source income again increased on the previous year, the Northern Territory Government, Alzheimer's Australia and the Australian Government remained the major sources of funding for the Association.


The Association's efforts to develop revenue flexibility, including by seeking out new funding sources will continue to be a focus in the coming year. Significant changes to revenue streams are not anticipated during coming year, though new bids will be needed for grants expiring in 2012/2013.

The Association has returned to a

balanced budget for the 2011/2012 period. While the Association anticipates renewal of major funding sources, it is reinforcing planning to address associated forward revenue, expenditure and business risks. Changes to State and Federal funding arrangements are being monitored closely.

The Chief Executive Officer Ruth Leslie-Rose and her team are to be highly commended for their achievements throughout a challenging year and their ongoing dedication to the sound financial management of the Association.

NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2011

NOTE 1. STATEMENT OF ACCOUNTING POLICIES

The accounting policies adopted by the Association are stated in order to assist in a general understanding of the financial statements. These policies have been consistently applied except as otherwise indicated.

(a) Reporting Entity

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Association's constitution and the Associations Act Northern Territory. The Committee has determined the Association is not a reporting entity, as it is their opinion, there are unlikely to exist users who are unable to command the preparation of reports tailored so as to satisfy all of their information needs.

(b) Accounting Policies

The financial report has been prepared on a modified accruals basis, is based on historical cost conventions and does not take into account changing money values or, except where stated, current valuations of non-current assets.

Unless otherwise stated the accounting policies adopted by Alzheimer's Australia NT Incorporated are consistent with those adopted in the previous financial year.

(c) Property, Plant & Equipment

Cost or valuation

Property, plant and equipment are carried at cost.

Depreciation

Depreciation is provided on the prime cost basis on all property, plant and equipment. All assets are depreciated over their estimated useful lives. Depreciation Rates applied are:

(d) Government grants

Grant income is recognised in the Statement of Income in the periods in which the relevant expenditure for which the grants are intended, is incurred; and is not recognised until related contractual conditions have been complied with.

NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2011 (CONT.)

NOTE 1. STATEMENT OF ACCOUNTING POLICIES (CONT.)

Grants received for the purchase of property, plant and equipment are brought to account as a liability under the heading "Deferred Grant Income". The amount of these grants is brought to account as income over the useful life of the property, plant and equipment purchased with the grant. The amount brought to account as income is the same as the amount brought to account as a depreciation expense for those items.

(e) Employee Entitlements

Amounts expected to be paid to employees in respect of their pro-rata entitlements to annual leave and long service leave are accrued annually in accordance with award, statutory and contractual requirements.

(f) Redundancy provision

A Provision for redundancy has been made with respect to obligation to employees that would crystalize in the event that all grant funded programs were discontinued.

(g) Going Concern

The future operations of Alzheimer's Australia NT Incorporated are dependent upon adequate future funding from relevant funding bodies to enable the Association to pay its debts as and when they fall due.

(h) Income Tax

Alzheimer's Australia NT Incorporated has been endorsed by Australian Taxation Office for GST concession and FBT exemption from 1 July 2005 and Income tax exemption from 1 July 2000.

(i) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of GST. Receivables and payables are recognised inclusive of GST. The net amount of GST recoverable from, or payable to, the taxation authority is included as part of the receivables or payables.
