In the twelve months since John McKellar's last Chairman's report an additional 75,000 of our fellow Australians have been diagnosed with Dementia.

This extremely compelling and confronting statistic contextualises all that we do at Alzheimer's Australia SA.

The Board together with the executive team has commenced a review of our strategic plan. Out of this review we have begun work on the Pathways Project. We are seeking to develop a map identifying the services and support required by our clients and their carers at each stage of their journey with dementia.

A focus of the past twelve months has been working to ensure our Association has the strategies in place necessary to meet the challenges of our continually changing environment.

The Board has been active in the area of governance. On behalf of all stakeholders, it is critical we have the appropriate policies and procedures in place. The Board has continued to monitor the establishment of the Australian Charities and Not for Profits Commission (ACNC). Our Association will meet all ACNC requirements.

The Board has identified the need to reduce our reliance on government funding by way of increasing our fee for service offerings. I assure you, our members, this will not be at the expense of our current clients, but rather by identifying products and services that attract new customers and revenue streams to AASA.

Work has continued on our accommodation needs. We have submitted plans to the Burnside Council which we believe will meet our accommodation needs on our current site for the next ten years. We are hopeful work will commence in the first half of next year.

The Board was most appreciative to be invited to be a part of the Volunteer recognition morning tea at Government House. It was a privilege to share the occasion with our wonderful Volunteers.

On behalf of the Board, I congratulate the Tender Loving Carers (TLC) group who held a number of successful functions this year. We look forward to continuing to support them in their fundraising endeavours.

The Association is appreciative of our ongoing relationship with the Rosemary Foundation which continues to be an important and valued source of funding.

In closing, I acknowledge the passing of two very special friends and supporters of AASA, Hon. Dr Kemeri Murray AO and Hon. Ian Wilson AM. Both provided outstanding service and support over many years and they will be greatly missed.

My thanks to the people of AASA led by our CEO, Kathryn Cunningham. We are indeed fortunate to have a Team of skilled and dedicated people.

Thanks also to my fellow Board Directors who freely give their time and skills to our Association.



FINANCIAL REPORT FOR THE YEAR ENDED 30TH JUNE 2013

It is pleasing to advise that management have continued to successfully tender for all the major grants plus new ones to increase the range of programs on offer to our members


Alzheimer's Australia SA recorded a surplus of \$278,347 for the financial year ended 30th June 2013.
