Community Group A is a non-profit association founded by Minnie Citizen in December 2014.

The association is mainly composed of Filipinos and 10% Australians who support and builds cultural awareness within the CALD community in WA.

The association recently celebrated its 10th year anniversary and hopes to continue to develop new artists, particularly in the youth sector, and the senior members of the Filipino Australian community in Perth.

The proposed project is entitled - 'Whispers of the Forgotten Tide'. There will be 2 presentations (16 & 17 Feb 2025) of this play written by Ms. Minnie Citizen, when she was a full-time carer for her father who suffered from Frontotemporal Dementia. The story comes from Filipino Folklore about a male dragon resembling a gigantic sea serpent. In this play, Minnie used this monster to symbolise dementia, and how it appears to eat up various memories from her father, whilst she was his full-time carer for 8 years. Q & A will follow each of the presentations.

To develop and help build understanding of dementia awareness within the CALD, particularly the Filipino community in Perth, Western Australia through dramatisation via a one act play.

To further raise the empathy and appreciation of dementia, not only for the diagnosed with it, but also for the people who surround them, such as immediate families, and friends in the community.

To empower the Filipino Australian community (currently over 40,000 Filipinos), in dealing, handling and coping with dementia related issues via a dramatic performance showcasing the powerful impact of theatre art.

- 3. More people from non-English background can be informed and be able to access information.


